**Test Conducted**

The Furniture and Furnishings (Fire) (Safety) Regulations 1988 S.I. No. 1324 (amended 1989, 1993 and 2010), Schedule 4 Part I Cigarette test for cover fabrics and Schedule 5 Part I Match test for cover fabrics. Smouldering cigarette test(ignition source 0) and Butane flame test(ignition source 1) of BS 5852 Part 1:1979.

**Conditioning**

The client claimed that the sample had not been treated with a fire-retardant chemical, the cleansed using a water-soak procedure at 40±1°C as described in BS 5651:1978 was not performed.

The specimens were conditioned immediately before the test for 72 h in indoor ambient conditions and then for at least 16 h in an atmosphere having a temperature of 20±5°C and a relative humidity of 50±20%.

At time of testing: Temperature between 15°C ~ 30°C and Relative humidity between 20% ~ 70%.

**Test Result**
